"Using the Honor System"

Start

All teams *(except No Limit Category, who must check in at Blue Wild Sunday between 1pm and 5pm. Categories that do not check in @ Bahia Basin, will default to "No Limit" category)* must check-in starting at 8:00 a.m. at the Bahia Cabana Basin and can begin competing after invocation. Coolers will be accepted starting @ 3pm with strict deadline of 4pm and must touch bahia Cabana designated dock area to count. Weigh-in starts @ 4:01 pm.

Territory

USA waters from Government Cut to the Boca Raton Inlet

Qualifying Fish and Fish Entry

Grouper: Blacks, Gags, Reds, Yellowfin

Snapper: Mangroves (min. 12"), Mutton, Cubera, Dog, Yellowtail, Schoolmasters (min. 12")

Other: Hogfish (min. 14"), Lionfish

Pelagic: Cobia, Mackerel (Spanish, King, Cero), Wahoo, Dolphin, Tuna (special permit required for Tuna), Greater Amberjack, Lesser Amberjack, Yellow Jack, White Margate, Oceanic Triggerfish (min. 14")

Fish Entry: Two (2) fish per specie and a maximum total of ten (10) fish PER TEAM *(conservation and sustainability starts with us).*

Florida Laws Strictly enforced **(FWC WILL BE PRESENT).**

Teams must weigh fish using single South Florida Freedivers issued stringer.


Placing based on weight and ties will be given to team with most species.
