

# **2012 San Diego Freedivers Blue Water Spearfishing Meet**



Join us for our Annual Blue Water Meet.

Entry in the San Diego Freedivers Annual Blue Water Meet spearfishing competition and Friends of the Children's Pool/Watermen's Alliance fundraiser includes a picnic, t-shirt, the opportunity to win great raffle prizes, and awards for the top three fish in each category. 100% of raffle profits will be donated to the FoCP/WA to aid in preserving ocean access. The picnic is a family event at no charge to SDF members to enjoy the food, fellowship, raffle, and awards ceremony. Non-member/guests may participate in the picnic, raffle, and awards ceremony festivities for \$10.00 per person.

**Date:** Saturday, August 18, 2012

**Meet Time:** From dawn until 4:00 PM.  
All fish entries must be presented for judging by the 4:00 PM deadline.  
All late catches will be disqualified.

**Location:** Shelter Island (Point Loma) at the grassy area across from Humphreys.  
Look for our canopy and flag in the grassy area just north of the Shelter Island Boat Ramp.

**Cost:** \$30.00 – San Diego Freedivers 2012 Members  
\$40.00 – Nonmembers

**Prize:** \$500.00- for largest single fish

**Categories:** Pelagic Fish (Yellowtail, White Seabass, Tuna, Barracuda, Dorado)  
Reef Fish

**Rules:** Largest single fish (by weight) wins the 1st Place award and \$500 cash prize, plus name and catch engraved on our perpetual trophy. Largest fish in the reef fish category will win an award. **ONLY ONE FISH ENTRY PER CONTESTANT.** Spearguns and pole spears only. Freediving only . . . no tanks, hooks, nets, traps, or bang sticks may be used to capture fish. Contest fish are limited to legal species and sizes as defined by the California Department of Fish and Game Ocean Sport Fishing Regulations. Specifically excluded from this contest are sharks, rays, sunfish (molas), broadbill swordfish, black seabass, and groupers. Boundaries are within a 40-mile radius from the Shelter Island Boat Ramp except north to the San Diego/Orange County line within State waters (3 mi.). All entrants must submit a completed and signed Registration/Release of Liability form with payment.

The deadline for receipt of all entries is midnight, Wednesday, August 15, 2012.
